

Dow Jones China Offshore 50 IndexSM

Fact Sheet

Stated Objective

To represent the largest stocks of companies whose primary operations are in mainland China but that trade on exchanges in Hong Kong or the U.S.

Key Features

- The index includes 50 of the largest stocks based on float-adjusted market capitalization. Stocks are selected to achieve representation of the 18 Supersectors defined by the Industry Classification Benchmark (ICB).
- Eligible stocks include H shares, red chips, ADRs/ADSEs and U.S.-only listed securities.
