Stated Objective

To measure the stock performance of U.S. companies in the Telecommunications sector.

Key Features

- The index represents the Telecommunications Industry as defined by the proprietary classification system used by Dow Jones Indexes.
- The index is one of ten indexes that together make up the Dow Jones U.S. IndexSM, which represents approximately 95% of U.S. market capitalization.
- The Dow Jones U.S. Telecommunications IndexSM was first calculated on February 14, 2000.
